COURT REJECTS FIRST LEGAL CHALLENGE BY D-LUX HOTEL

The D-Lux Hotel, which was recently denied a new business license by the Village Manager and Board, sought a temporary restraining order and injunction from the court allowing them to stay open while they challenged the underlying decision by the Village to deny a new license. The hearing on this motion was July 15, 2008. The emergency motion for a temporary restraining order preliminary injunction was denied. The judge denied it for two reasons: (1) The new owners of the D-Lux (children of former owners) do not have a clear protectible right given that they are new license applicants; and (2) they did not show that they have a clear likelihood of success on the merits.

The motel was shut down as of midnight July 15, 2008 and will remain closed until the court rules on whether the decision by the Board should stand. The standard the court applies in reviewing the decision by the Village Board is whether it was "arbitrary and capricious". It obviously is the position of the Village that the decision was anything but that, with clear reasoning articulated in a lengthy written decision based upon facts.

The next step is a court hearing on August 12, 2008. At that time, the court is expected to set a schedule for hearing the arguments by both sides on the license denial and date when a final ruling will be issued as to whether the motel will be allowed to re-open or stay closed permanently.

The Oak Lawn Police Department is currently in the process of implementing a village wide McGruff House Program. A McGruff House is a temporary haven for children who find themselves in a frightening or dangerous situation. A McGruff House in the neighborhood shows someone is looking out for the children. The McGruff House Program is a partnership among law enforcement, schools, and community groups. Having a McGruff House in the neighborhood indicates someone is watching out for its children.

To begin this worthwhile program we are looking for residents who would be willing to allow their house to become a McGruff House. Interested parties can pick up a McGruff House Program Participant Application at the Police Desk inside the Oak Lawn Police

After applications are received they will be screened and qualified applicants will be notified to the date and time of an orientation and training session. We will hold several sessions throughout the summer to accommodate every ones summer plans. Our goal is to have to program up and running at the beginning of the next school year.

McGruff House participants agree to help children as they go to and from school and play in the neighborhood by:

- Telephoning appropriate authorities for help.
- · Reassuring or assisting children who are lost or frightened.
- Assisting children who have medical emergencies by contacting appropriate professionals.
- Assisting children who fear becoming victims of personal crime by summoning qualified help.
- Assisting children who have been victimized by crime by calling appropriate authorities.
- Reporting crime and suspicious activities to law enforcement officials, providing as much information as possible.
- · Abiding by the restrictions and requirements of the McGruff House Network.

Bicycle Safety

Head injuries are the leading cause of death and permanent disability related to bicycle crashes. Bicycle helmets have been shown to reduce the risk of head injury by at least 85%. Unfortunately, only about 15-25% of children on bikes wear helmets.

When purchasing a helmet, it should have a rating. Look at the inside of the helmet for a green or blue Snell sticker, meaning the helmet passed the Snell Foundation's tests for safety; an F1447 certification label by the American Society for Testing and Materials (ASTM); or a compliance label from the U.S. Consumer Products Safety Commission (CPSC).
