AN ORDINANCE AMENDING TITLE 11 CHAPTER 1 SECTION 5 OF THE VILLAGE OF OAK LAWN CODE "LICENSE FEES ENUMERATED"

WHEREAS, Section 6(a) of Article VII of the 1970 Constitution of the State of Illinois provides that any municipality which has a population of more than 25,000 is a home rule unit, and the Village of Oak Lawn, Cook County, Illinois, with a population in excess of 25,000 is, therefore, a home rule unit and, pursuant to the provisions of said Section 6(a) of Article VII, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and to incur debt; and

WHEREAS, the President and Board of Trustees find that it is in the best interests of the citizens of the Village of Oak Lawn to amend Title 11 Chapter 1 Section 5 of the Oak Lawn Village Code entitled "LICENSE FEES ENUMERATED" and;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OAK LAWN, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

SECTION 1: The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

SECTION 2: That Title 11, Chapter 1, Section 5 of the Oak Lawn Village Code is hereby amended by deleting strikethrough language and incorporating additional language as follows:

The license fee to be paid annually to the administrative services department for the various classes of vehicles hereinafter set forth shall be as follows:

- A. Motorcycles: Motorcycles, motor bicycles, motor scooters and mopeds: \$19.00.
- B. Passenger cars, etc.: Passenger cars, hearses, state licensed recreational vehicles and ambulances: \$25.00. Upon presentation of suitable proof that 1 of the owners of record of the passenger car is 62 years of age or older, such person shall pay the sum of \$5.00 per annum. Spouses shall be allowed only 1 senior citizen discount passenger car license, as set forth above, between them, no matter how many passenger cars are owned in whole or in part by the spouses.

C. Trucks:

3,000 pounds to 8,000 pounds, "B plate": \$35.00

8,001 pounds to 12,000 pounds, "D plate": \$41.00

- 12,001 pounds to 26,000 pounds, "F and H plates": \$71.00
- 26,001 pounds to 80,000 pounds "J, K, L, N, P, Q, R, S, T, V, X and Z plates": \$108.00.
- D. Buses: \$19.00, provided such buses are used for public transportation.
- E. All vehicles owned by state, county, township, village or incorporated towns: \$14.00.
- F. Agricultural vehicles: \$24.00.
- G. Charitable vehicles: Motor vehicles which are registered with the state as charitable vehicles and display a "CV plate": \$10.00.
- H. Veterans' vehicles: 1 motor vehicle owned by any permanently disabled veteran and containing state disabled veteran license plates may receive a vehicle license at no fee. Said no fee vehicle license may also be issued to a disabled veteran who has tendered proof of disability supported by documentation of disability issued by the Illinois veterans commission, notwithstanding the fact that the motor vehicle in question does not contain state disabled veteran license plates. Consistent with 625 Illinois Compiled Statutes 5/3-609, any vehicle license(s) issued for any additional motor vehicle(s), owned by any disabled veteran who has received a no fee vehicle license, shall be issued at the applicable license fee rate as set forth in this section.
- I. Vehicles for disabled Person(s) with a Disability: Any motor vehicle owned by any permanently disabled person with a disability, other than veterans who qualify under subsection H of this section, upon presentation of proof of permanent disability as provided by the Illinois Secretary of State consistent with 625 Illinois Compiled Statutes 5/3-616: \$10.00 \$5.00.

Vehicle stickers must be affixed to the vehicle for which said sticker was purchased no later than July 31 of each year. Failure to display a valid vehicle sticker will be cause for penalty as outlined in this title.

Vehicle licenses may only be purchased at the village hall, through the mail, or via the internet on forms provided for same between June 1 and July 31. All information required on said forms must be completed in order to procure a vehicle sticker. The required forms must be accompanied by a dated state of Illinois vehicle registration.
